**MEETING MINUTES**

July 17, 2024

Chairman Elliott L. Temple was absent. There being a quorum present, the regular order of business was called.

Mr. Fine led the Pledge of Allegiance.

Ms. Tanika Starks introduced herself as the hearing officer overseeing these proceedings and addressed the audience and board on the administrative procedures for hearings.

Mr. Joseph made a motion to accept the minutes of the May 15, 2024, Residential Building Subcommittee Meeting. Mr. Morse seconded. The motion passed.

Mr. Beavers stated the proceedings were being observed by a representative of the Louisiana Attorney General's Office.

Mr. Joseph called for any public comments; there was no response.

Mr. Landreneau entered the exhibit packet into evidence, and it was admitted. Mr. Emery made a statement to the board. The board questioned Mr. Emery. 


